Admission: There will be an admission fee of \$5.00 for adults, and \$3.00 for students/senior citizens. Programs will be available at a cost of \$3.00 for session.

Awards: Medals will be awarded to the top twelve places 1st – 12th in each event, and ribbons to places 13-18. Separate team awards will be presented to the top team for boys & girls.

Results: One copy of the final results will be available at the end of the meet for all participating Teams. Extra meet results can be ordered at the admission table for an additional fee.
