Facility Information	The Secaucus Swim Center is a 6 lane 25 yard pool, with Colorado Timing. There is gallery seating for all participants and spectators. The depth of the pool at the block end is 7 feet; the depth of the pool at the turn end is 4 feet.
Pool Certification Statement	The competition course has not been certified in accordance with 104.2.2C(4). Note that this statement is a required meet announcement statement, and refers to the pre-certification of the pool length measurement in regards to National and World Record swims which may occur in the pool. The fact that this pool is not certified in accordance to 104.2.2C(4) does not impact on the validity of the times achieved in this pool. Times swum at this meet will in fact be entered in SWIMS and are eligible for qualifying for any other USA Swimming sanctioned competition.

E-Mail entry file to: entries1@juno.com.</p> <p>There will be no refunds after the entry deadline except for events that may be scratched from meet by the Entry Coordinator or Meet Director, or as otherwise directed by NJ Swimming. Entries will be acknowledged within 48 hours of receipt.</p> <ul style="list-style-type: none"> • All entries will be accepted on a first come basis. • Mail the signed waiver and entry fee check to: Be Smartt, Inc., 604 Paxson Avenue, Mercerville, NJ 08619 • Entry Fee Summary forms, verification forms, waiver release, and fees must be received no later than 7:15am, Sunday November 17th, 2013. • Team entries will be considered accepted when the host club accepts the entries. • Meet Entries will be taken until the meet fills. The host club must stay within the four hour per session rule. • It is not necessary to use overnight or express mail to send hard copy and check, which are sent in support of an e-mailed entry.
Meet Format Waiver:	<p>The host club has the right to change the format of the meet with the approval of the sanctioning chair and either the age group or senior chair. These changes would be made for a more efficient swim meet for the swimmers and the host club. Reasons for these changes include:</p> <ul style="list-style-type: none"> • To allow more swimmers to swim. • To conform to facility capacity limits or for facility safety concerns. • To condense the meet into smaller time period. <p>Some of the changes that may be made include: 1) add a session, 2) limit heats in distance events, 3) condense sessions and 4) eliminate relays.</p>



Meet Requirement Statement:	In order to be eligible for the New Jersey Zone Championship Team or for NJ Swimming Athlete Reimbursement for sectional and national level meets, NJ Swimming policy stipulates certain participation requirements. As a New Jersey Swimming sanctioned meet, this meet counts towards those participation requirements.
Coaches Eligibility:	<ul style="list-style-type: none"> • All coaches “on the deck” must be currently registered coach members of USA Swimming. • All coaches must have coaching cards when picking up check-in sheets. • All coaches must have coaching cards when getting food from concessions.

Swimmer Eligibility:	<ul style="list-style-type: none"> • All swimmers must be members of USA Swimming to enter and compete in this meet. • All transfer swimmer(s) must swim unattached for 120 days from their last attached competition. Swimmers must use an UN- (New Team Alpha Code) as their team affiliation. All Unattached swimmers must be listed on the team’s official waiver entry form. • There will be 10 & Under, 11-12, and 13-Over Events • The 13-Over events will be combined age groups: 13-14 and 15-Over. • There will be no qualifying times for this meet. • Swimmers will be permitted to compete in FOUR (4) individual events per day. • Age for this meet is calculated as of: Sunday, November 17th, 2013
Swimmers Unaccompanied by a USAS Certified Coach:	Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a USA Swimming member coach, it is the responsibility of the swimmer or the swimmer’s legal guardian to ensure compliance with this requirement.
USAS Deck Change Policy Statement:	Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited.
Meet Format:	<ul style="list-style-type: none"> • This meet will be run in accordance to current USA Swimming Rules. • This meet will be run as a timed final meet. • This meet will be deck seeded with coaches checking in/scratching all swimmers. When the seeding has been posted, swimmers will report to the blocks on their own.

Warm-up Procedures	<ul style="list-style-type: none"> • Warm-ups will be run under New Jersey Swimming Warm-up and Safety Guidelines. Warm-ups will include general warm-up lanes, sprint lanes, and pace lanes. • Swimming Equipment is not allowed in the competition pool during all warm-up sessions. This includes kick boards, hand paddles, and pull buoys. • All swimmers are entitled to a fair and comparable warm-up. All teams must receive the same opportunities for warm-up lanes, sprint lanes, and pace lanes. • All swimmers must enter the pool feet first from the starting end of the pool. • New Jersey Swimming officials will monitor warm-ups. • All general warm-up lanes will swim in a counterclockwise direction. • Warm-ups will consist of two (2) 25-minute warm-up sessions with teams assigned to a session, followed by a 10-minute session of all sprint lanes for all teams.
Entry Times	<ul style="list-style-type: none"> • New Jersey Swimming does not allow 'NT' or 'No Time' to be used as an entry time. • All entry times must be in short course yards.
Check-In	<ul style="list-style-type: none"> • All check-in sheets must be turned into the scoring table 35 minutes before the start of each session. Swimmers that are swimming will have a line through their name. Swimmers that are being scratched will have their names circled with a "SCR" next to the circle. Swimmers scratching a single event will have a line through their name and the event number circled with "SCR" next to the circle. • Failure to follow this procedure may result in the swimmer(s) being scratched from the session.
Starts	The host club will determine if 'Fly-over/Over-the-top' starts will be used after a time line has been produced. This information will be posted in the pre-meet information e-mailed to coaches.
Scoring:	<ul style="list-style-type: none"> • Team Scoring will not be kept.
Awards:	<ul style="list-style-type: none"> • Medals will be awarded for the top three swimmers in each individual event. • Medals will be awarded for the top three swimmers in both the 13-14 and 15-Over in the 13-Over age group individual events.
Entry Fees:	<ul style="list-style-type: none"> • Individual Entry Fee: \$4.00 • Make checks payable to: JFAC • Host club has the right to scratch teams/swimmers for lack of payment of entry fees, lack of completed and signed waiver forms. • Special Notice: All entries fees must be paid no later than Session Check-in. If a team fails to make payment by that time all their swimmers may be scratched, at the discretion of the Host Team.
Admissions and Programs:	Admission will be \$5.00 per session. Cost of Program will be \$5.00 for the entire meet or heat sheets might be available for a fee.
Results:	<ul style="list-style-type: none"> • Results will be e-mailed to teams participating in the meet. • Results will be posted on the meet website.
Host Club Responsibilities:	<ul style="list-style-type: none"> • The host club will provide a single timer in each lane through out the meet. • The host club will e-mail entry verification back to the participating clubs. • The host club will create a warm-up schedule that will be fair and equal to all teams. • The host club will create timing assignments that are fair and equitable with as many teams participating as possible. • Warm-up schedules and assignments, and timing assignments will be e-mailed to all participating clubs and posted on the websites: http://www.bbswim.org & www.besmartinc.com no later than 1 week before the meet.
Participating Club Responsibilities:	<ul style="list-style-type: none"> • Participating clubs must help with timing assignments and MUST SUPPLY THEIR OWN STOPWATCHES. Timing assignments will be e-mailed to participating clubs and posted on the swim meet website: http://www.bbswim.org & www.besmartinc.com 1 week prior to the meet. • Participating club parents must stay off the pool deck except for timing assignments. • Participating clubs should help with officiating whenever possible. List the club contact for club officials on the meet summary.
Concessions:	Food and drink will be available at reasonable cost.
