Location	The pool is located in the Sonny Werblin Recreation Center on the Busch Campus at Rutgers University in Piscataway, New Jersey. The Center’s main number is 732-445-0460. <i>This number is for emergencies only.</i> All calls regarding this meet should be directed to the Meet Director.
Facility Information	The Werblin competition pool is a 50 meter, 8-lane pool with a minimum depth for diving of 6 feet. There are two auxiliary pools, known as “patio pools” (for warm-up and warm-down), and seating for 1,000 spectators, including 400 chair-backed seats. The remaining seating is bleacher style.
Pool Certification Statement	The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming.
Audio/Visual Recording Statement:	Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.

Meet Format Waiver	<p>The host club has the right to change the format of the meet with the approval of the sanctioning chairman and either the age group or senior chairman. These changes would be made for a more efficient swim meet for the swimmers and the host club. Reasons for changes include:</p> <ul style="list-style-type: none"> ▪ To allow more swimmers to swim. ▪ To conform to facility capacity limits or for facility safety concerns. ▪ To condense the meet into a shorter timeframe. <p>Some of the changes that may be made include: 1) adding a session, 2) heat-limiting distance events, 3) condensing sessions, 4) combining heats, and 5) eliminating relays.</p>

Meet Requirement Statement	In order to be eligible for the New Jersey Swimming Zone Championship Team or for NJ Swimming Athlete Reimbursement for sectional and national level meets, NJ Swimming policy stipulates certain participation requirements. As a NJ Swimming sanctioned meet, this meet counts towards those participation requirements.



Coaches Eligibility	<ul style="list-style-type: none"> ▪ All coaches on the deck must be current coach members of USA Swimming. ▪ Coaches must show their coaching card for entrance to facility. ▪ Coaches must show their coaching card before picking up any meet information or scratch sheets. ▪ Coaches must have their coaching card visible at all times while on deck. ▪ Coaches must have a visible coach's card when entering hospitality area.
Swimmer Eligibility	<ul style="list-style-type: none"> ▪ All swimmers must be a member of USA Swimming to enter and compete in this meet. ▪ All swimmers must be listed on a team's official entry form to be eligible to participate in this swim meet in any event including relays. ▪ All transfer swimmers must swim unattached for 120 days from their last attached competition. Swimmers must use "UN-(New Team Alpha Code)" as their team affiliation. All unattached swimmers must be listed on their team's official waiver entry form. <p>Age Groups That Will be Offered</p> <ul style="list-style-type: none"> ▪ All events will be offered as Open events. <p>Individual and Relay Limits</p> <ul style="list-style-type: none"> ▪ Swimmers may compete in up to three 3 individual events. ▪ Swimmers may compete in two (2) relays. <p>Age at Meet</p> <ul style="list-style-type: none"> ▪ Age determination date for this meet is Wednesday July 2nd, 2014
Entry Times	<ul style="list-style-type: none"> ▪ New Jersey Swimming does not allow "NT" or "No Time" to be used as an entry time. ▪ All entry times must be in long course meters. ▪ Converted times from SCY or SCM are acceptable for this meet.
Meet Format	<ul style="list-style-type: none"> ▪ This meet will be run in accordance with current USA Swimming rules. ▪ This meet will be run as a timed final meet. <p>Seeding Procedure</p> <ul style="list-style-type: none"> ▪ This meet will be deck seeded with coaches checking in and/or scratching all swimmers. After the heats have been posted, swimmers will report to the blocks on their own.
Scoring	<ul style="list-style-type: none"> ▪ Team Scoring will not be kept.
Awards	<ul style="list-style-type: none"> ▪ There will be no awards.
Results	<ul style="list-style-type: none"> ▪ Results will be sent to participating teams via email at the conclusion of the meet and posted at www.besmarttinc.com
USA-S Racing Start Certification Statement	Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a USA Swimming member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
USA Swimming Deck Change Policy	Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited.

<p>Warm-Up Procedures</p>	<ul style="list-style-type: none"> ▪ Warm-ups will be run under New Jersey Swimming Warm-up and Safety Guidelines and will include general warm-up lanes, sprint lanes, and pace lanes. ▪ Since there are neither time qualifications nor age-group separation, the Host Team will be diligent about organizing a warm-up that provides a safe warm-up environment for younger/smaller swimmers. <p>Entry Into Pool</p> <ul style="list-style-type: none"> ▪ All swimmers must enter the pool from the starting end of the pool. <p>Host Team Monitoring Warm-Ups</p> <ul style="list-style-type: none"> ▪ New Jersey Swimming officials will monitor warm-ups. ▪ All general warm-up lanes will swim in a counterclockwise direction. <p>Warm-Up Schedules</p> <ul style="list-style-type: none"> ▪ The warm-up sessions will be 30-minute each, divided by teams. There will be designated sprint lanes and pace lanes during the last 10 minutes of each session, unless additional warm-up sessions are warranted.
<p>Check-In</p>	<ul style="list-style-type: none"> ▪ All check-in sheets must be turned into the scoring table 35 minutes before the start of each session. Swimmers who are competing will have a line through their name. Swimmers who are to be scratched for all events in the session will have their names circled with "SCR" noted next to the circle. Swimmers scratching a single event will have a line through his or her name and the event number circled with "SCR" next to the circle. ▪ Failure to follow the check-in procedure may result in the swimmer(s) being scratched from the session.
<p>Starts</p>	<p>"Fly-over" ("over-the-top") starts may be used at the discretion of the meet referee.</p>
<p>Heat Limits</p>	<ul style="list-style-type: none"> ▪ There are no heat-limited events.
<p>Entry Fees</p>	<ul style="list-style-type: none"> ▪ Individual Entry Fee: \$5.00. ▪ Relay Entry Fee: \$9.00. ▪ Make checks payable to Montclair YMCA
<p>Admissions and Programs</p>	<ul style="list-style-type: none"> ▪ Admission will be \$7.00. ▪ Heat sheets will be available at \$3 each.
<p>Entries</p>	<ul style="list-style-type: none"> ▪ In accordance with New Jersey Swimming policy, team entries may be submitted by e-mail to entries1@juno.com. ▪ All entries must be Hy-Tek program entries as an attached file to an e-mail. Subject line should include MYM Challenge 2014 ▪ The meet entry coordinator will respond to e-mails entries within 48 hours. If you do not receive an e-mail response within 48 hours, assume that your email has not been received. It then becomes the e-mailer's responsibility to make sure that the host club's meet entry coordinator receives the e-mail. If you do not receive an e-mail response, you must contact the entry coordinator by email or phone. ▪ An Entry Summary along with a signed New Jersey Swimming waiver and a check for all entry fees must accompany or follow each entry. ▪ Accuracy of seed times is essential. Incomplete entries will not be accepted. ▪ Deck, phone, and/or faxed entries will not be accepted.
<p>Host Club Responsibilities</p>	<ul style="list-style-type: none"> ▪ Provide a single timer in each lane throughout the meet. ▪ Have stopwatches available for volunteers helping to time. ▪ Create a warm-up schedule that will be fair and equitable to all teams. This warm-up schedule will be e-mailed to all participating clubs no later than one week before the meet. ▪ Create timing assignments that are fair and equitable with as many teams participating as possible. These timing assignments will be e-mailed to all participating clubs no later than one week before the meet and posted at www.besmartinc.com.
<p>Participating Club Responsibilities</p>	<ul style="list-style-type: none"> ▪ Help with timing assignments (mandatory). Timing assignments will be e-mailed to participating clubs one week prior to the meet and posted at www.besmartinc.com ▪ Parents must stay off the pool deck except to fulfill timing assignments. ▪ Should help with officiating whenever possible. List the club contact for club officials on the meet summary.
<p>Concessions</p>	<ul style="list-style-type: none"> ▪ Rutgers University may have food concessions available.
<p>Vendor</p>	<ul style="list-style-type: none"> ▪ A swim vendor may be in attendance.

Directions:	<p><i>Directions to Sonny Werblin Recreation Center:</i></p> <p>Address: 656 Bartholomew Rd, Piscataway Campus: Busch Campus</p> <p>Garden State Parkway Southbound Turn off at Exit 129 and take the New Jersey Turnpike South. Exit the Turnpike at Exit 9, bear right after the tollbooths and follow signs for Route 18 North—New Brunswick. Stay to the left to continue on Route 18 North. Proceed along Route 18 North. After approximately 3.7 miles Route 18 will cross the Raritan River. Continue on Route 18 North to the Campus Rd exit ramp on the right. Follow Campus Road to a traffic circle. Turn right at the traffic circle onto Bartholomew Rd. The Recreation Center is on your left.</p> <p>Garden State Parkway Northbound Turn off at Exit 105 and follow signs for Route 18 North. After approximately 24 miles, you will pass the entrance for the New Jersey Turnpike. Continue on Route 18 North. After approximately 3.7 miles Route 18 will cross the Raritan River. Continue on Route 18 North to the Campus Rd exit ramp on the right. Follow Campus Road to a traffic circle. Turn right at the traffic circle onto Bartholomew Rd. The Recreation Center is on your left.</p> <p>Interstate 287 Turn off at Exit 9 Bound Brook/Highland Park. Proceed East on River Road towards Highland Park. Continue on River Road and you will pass under the overpass for Route 18. Turn left at the next traffic light onto North. Take the next exit on Route 18 North, Campus Road. Follow Campus Road to a traffic circle. Turn right at the traffic circle onto Bartholomew Rd. The Recreation Center is on your left.</p> <p>New Jersey Turnpike Exit the Turnpike at Exit 9, bear right after the tollbooths and follow signs for Route 18 North—New Brunswick. Stay to the left to continue on Route 18 North. Proceed along Route 18 North. After approximately 3.7 miles Route 18 will cross the Raritan River. Continue on Route 18 North to the Campus Rd exit ramp on the right. Follow Campus Road to a traffic circle. Turn right at the traffic circle onto Bartholomew Rd. The Recreation Center is on your left.</p> <p>US Route 1 Turn off at exit marked Route 18 North—New Brunswick. Proceed along Route 18 North. After approximately 3.7 miles Route 18 will cross the Raritan River. Continue on Route 18 North to the Campus Rd exit ramp on the right. Follow Campus Road to a traffic circle. Turn right at the traffic circle onto Bartholomew Rd. The Recreation Center is on your left.</p> <p>Rutgers will have posted signs indicating which of the parking lots are for the swim meet. Please use one of these lots. Rutgers campus police may ticket automobiles that are parked in lots other than those designated for the swim meet!</p>
